Hello,

In lieu of re-drawing all lines, I took the Option 3 from the drafts we were presented at the 9/20/2017 meeting and made the following modifications:

PB80 moves **94** students from **Oakleigh** to **Carney** Elementary (PRO: Eliminates satellite)

PB75, PB76, PB77 moves **68** students to **FROM Carney TO Seven Oaks** (PRO: Makes Joppa Rd - a main road - the dividing line).

PB113 and **PB89** moves **33** students **FROM Perry Hall ES TO Gunpowder** (PRO: Puts those blocks on same side of Belair Rd as Gunpowder, although now it's a left turn)

PB46 and **PB145** moves **34** students **FROM NE School to Perry Hall ES.**

PB49, PB50, and **PB51** moves **64** students **FROM Joppa View TO NE School** (PRO: Improves Option 3 which had Joppa View 65 students over.)

Modify **PB138** so that the horseshoe at the bottom is in **PB21**, zoned to **Chapel Hill** (This is a part of Glenside Farm, which is in **PB21**).

PB139 (and the horseshoe of **PB138** made part of **PB21**) moves around **35** students (not sure how many would be in the horseshoe) **FROM NE School TO Chapel Hill.**

PB18, PB8, PB5 moves **7** students **FROM Chapel Hill TO Vincent Farm.**

Based on the starting point from Option 3, with these changes, we'd see these numbers below. Every school is one classroom or less over capacity, and we give Vincent Farm a little breathing room for now:
