

We are 0.3 miles door-to-door from our school and it is why we live in this community. Being in such close proximity to the school, it is easy to see that any change would fully disrupt transportation and pedestrian patterns for the students in PB 109. Dear Committee Members,

I am writing to express strong support for Option B.

When comparing Options B and C, I see many benefits to choosing Option B:

Option B is beneficial in terms of a decrease in enrollment for three schools involved in the study (Carney, Chapel Hill, Perry Hall)

Option B is neutral in terms of no change in enrollment compared to Option C for 6 schools (Gunpowder, Joppa View, Kingsville, Oakleigh, Seven Oaks, Vincent Farm)

Option B would keep enrollment at the new school under capacity, which is an important component of this boundary study, while also providing relief to many of the neighboring schools

Option B is the best compromise between Option A (the most even capacity split across all schools) and Option C (leaves the most schools well over capacity).

If the committee finds Option C to be a preferred choice over Option B, I strongly suggest this revision:

If PB 40, PB 41, PB 43, PB 44, PB 45 were added to the new school, more balance in terms of enrollment would be provided. The new school would still be well under capacity and this revision would benefit Perry Hall Elementary by providing a decrease in enrollment.

Thank you for the time you have invested in this boundary study up to this point and thank you for your consideration of this suggestion as we enter the final stages of this process.

I am appalled that one neighborhood can draw so much attention away from the data & objective of this boundary study. The goal is to balance enrollment at area elementary schools, including the new school. It is my hope that you will see past opinions so that your focus will remain on the data and projected enrollment figures. Having one community with a loud voice is great, but shouldn't override those neighborhoods that are not as involved. There are neighborhoods in the Vincent Farms district who do not realize that this study affects the quality of education for their children at Vincent Farms. I'd like to send this reminder to make decisions driven by data which have the best outcome for ALL affected children, not just one community who is resistant to change. After their children leave the school, the district will be left with an imbalance of enrollment, potentially under-serving a lot of children.

Thank you for listening to everyone and considering opinions on all sides, but please remain focused on the data and the long term future of these schools. I am against the additional options presented. Thank you!
