Enrollment Relief Plan for Deep Creek Elementary and Dogwood Elementary Schools

Executive Summary

Early each school year, staff from the Office of Strategic Planning meets with the Area Assistant Superintendents to discuss student enrollment. Using the September 30th enrollment numbers, the enrollment and capacity of all schools are reviewed. During this time, plans are discussed to provide relief to schools operating over the State Rated Capacity (SRC). The plans discussed range from simple and low-cost to complex and costly. The simple and low-cost plans may include a review of the current room use resulting in recommendations for adjustment that will increase building capacity or the placement of a relocatable classroom. The more complex and expensive plans may include redistricting from an over-capacity school to one with excess capacity or the construction of an addition or a new school.

Dogwood and Deep Creek Elementary Schools have operated at a level that exceeds SRC for the past few years. Relocatable classrooms have been used to provide relief but they no longer represent an optimal strategy.

The enrollment relief plan for both Dogwood and Deep Creek Elementary Schools is to annex the prekindergarten and kindergarten students to nearby schools. The annexed students at Dogwood will move to Featherbed Lane Elementary School. The annexed students at Deep Creek will relocate to Hawthorne Elementary School. Both Featherbed Lane and Hawthorne Elementary Schools have the excess capacity to accommodate these students.

Staff is recommending the proposed annexation plan as being in the best interest of children by providing the most relief while impacting the least number of children.





- Projected to remain over capacity over next 10 years

Adjacent Elementary School Profiles

- Capacity available at nearby schools:
 - Chadwick ES (-2 students)
 - Featherbed Lane ES (-124 students)
 - Winfield ES (-38 students)
 - Woodbridge ES (-20 students)
 - Chadwick ES, Winfield ES and Wodbridge ES are expected to maintain stable populations over the next 10 years.
 - Featherbed Lane ES enrollments are expected to decline slightly over the next 3 years, then climb steadily over the following 7 years.

Advantages/Disadvantages of Annexing

Advantages:

- Provides relief with least disruption (smallest number of students and smallest number of moves)
- Does not disadvantage any single neighborhood or community
- Proximity of receiving schools (1.7 miles Dogwood/Featherbed and 2.9 miles for Deep Creek/Hawthorne)
- Allows realignment of relocatable units
- History of successful implementation
- Effective and efficient use of resources

Disadvantages:

• Potential split of siblings
