[The Board of Education has the responsibility for maintaining the minimum program of instruction guaranteed by the state statutes and of initiating improvements beyond the minimum.

The officers and employees of the system are responsible for maintaining the program of instruction in accordance with the provisions of the Constitution of the State, the acts of the Legislature, the rules and regulations of the State Board of Education and the rules and regulations of the Board of Education of Baltimore County.

The Superintendent of Schools shall provide principals and teachers with instructional materials covering all instruction approved by the Board of Education.]

THE BOARD OF EDUCATION IS COMMITTED TO PRODUCING GRADUATES WHO HAVE THE KNOWLEDGE, SKILLS, AND ATTITUDES TO REACH THEIR POTENTIAL AS RESPONSIBLE, PRODUCTIVE CITIZENS, TO BE SUCCESSFUL IN COLLEGE AND THE WORK PLACE, AND TO BE COMPETITIVE IN THE GLOBAL ECONOMY.

CURRICULUM IN BALTIMORE COUNTY PUBLIC SCHOOLS MUST DELINEATE A PRESCRIBED COURSE OF STUDY FOR ALL GRADES AND COURSES TO IDENTIFY WHAT STUDENTS SHOULD KNOW AND BE ABLE TO DO.

THE BOARD AFFIRMS THE NEED FOR ARTICULATION AND COORDINATION OF CURRICULUM ACROSS CONTENT AREAS AND GRADE LEVELS.

CONSISTENT WITH THE GOALS OUTLINED IN THIS POLICY AND THE BLUEPRINT FOR PROGRESS, THE SUPERINTENDENT SHALL DEVISE STANDARDS OR PROCEDURES FOR THE DESIGN, DELIVERY, AND EVALUATION OF THE CURRICULUM.
