#### Statement of Issues Addressed By the Proposed Policy

Policy and Rule 1310 are being proposed to be deleted altogether, as information on fund raising is covered in Policy and Rule 2361, and Policy and Rule 3125.

#### Cost Analysis and Fiscal Impact on School System

#### Relationship to Other Board of Education Policies

Policy and Rule 2361 address the distribution of flyers by students for fund raising activities. New proposed language in Policy and Rule 3125 address the guidelines for fund raising activities.

Most school systems have policies for school activity funds. Specific guidelines vary somewhat.

#### COMMUNITY RELATIONS: Use of School Facilities

#### Fund Raising

Campaigns for collecting funds from students by persons or organizations, charitable or otherwise, outside of the public school system, are not permitted in any Baltimore County public school. Students shall not be used for the solicitation of funds for charitable campaigns within the public schools of Baltimore County.

Charitable organizations must secure permission from the Office of the Deputy Superintendent to disseminate information about fundraising activities. However, these projects are not to be classified as school activities, and students are not permitted to solicit funds as representatives of the Baltimore County Public Schools.

School affiliated organizations may conduct fund-raising activities under the auspices of the local school, provided such activities are in accordance with all established policies and rules. All organizations conducting fund-raising activities in the name of the school must have provisions for an annual audit of their financial records. Reports of such audits must be maintained by the organization and be available for inspection upon request.
