Statement of Issues Addressed by the Proposed Policy

This policy was last revised in 1968. Staff members have made additions to the original statement, in accordance with the *Annotated Code of Maryland*, Education Article, Section 7-103 and 7-105, and have added an amendment to allow for those staff members and students who may not wish to participate, to be excused.

<u>Cost Analysis and Fiscal Impact on School System</u> There is no fiscal impact on the school system.

<u>Relationship to Other Board of Education Policies</u> Policy 6115.1 (6116), Patriotic Exercises

Legal Requirement

Annotated Code of Maryland, Education Article, Section 7-103 and 7-105, each local school system shall determine which date shall be the date for holiday observances. The public schools shall devote a part of the day to appropriate exercises for any day of national significance.

Similar Policies Adopted by Other Local School Systems Policies from Anne Arundel, Fairfax, Frederick, Harford, and Montgomery Counties were reviewed and analyzed.

INSTRUCTION

C[eremonies] OMMEMORATIONS and Observances

Commemoration AND OBSERVANCE of special days and events shall be arranged [to] FOR the [end] PURPOSE OF [that the effective observation of these occasions is a definite and valuable part of the school] ENRICHING THE INSTRUCTIONAL program. SCHOOLS SHALL DEVOTE A PART OF THE DAY TO APPROPRIATE EXERCISES FOR DAYS OF NATIONAL SIGNIFICANCE. THE SUPERINTENDENT SHALL DETERMINE WHICH DATES SHALL BE DESIGNATED FOR HOLIDAY OBSERVANCES.

ANY STUDENT OR STAFF MEMBER, WHO WISHES TO BE EXCUSED FROM THE PARTICIPATION IN COMMEMORATION OF SPECIAL DAYS, SHALL BE EXCUSED.
