Policy Analysis for Board of Education Policy 4133 <u>Tutoring</u>

Statement of Issues or Questions Addressed

Policy 4133 is being recommended for revision to include a provision that, with the exception of school sponsored programs, would prohibit teachers regularly employed in a school from tutoring for compensation any student whom he or she is currently teaching. Deletion of Rule 4133 is being recommended.

[It is expected that every effort will be made by the principal and teacher to help the child with his/her difficulties at school before recommending that parents engage a tutor. The Board of Education believes that by maintaining a high-quality instructional staff and providing for a rich, varied curriculum, the need for individual tutoring is minimized.

Should, however, individual tutoring be recommended in exceptional cases, the Superintendent of Schools is directed to establish such rules as will protect both the school system and the teachers from charges of conflict of interest.]

WITH THE EXCEPTION OF SCHOOL SPONSORED PROGRAMS, TEACHERS REGULARLY EMPLOYED IN A SCHOOL SHALL NOT TUTOR FOR COMPENSATION ANY STUDENT WHOM HE OR SHE IS CURRENTLY TEACHING.
