# POLICY ANALYSIS FOR BOARD OF EDUCATION POLICY 7110 <u>DETERMINING NEEDS</u>

#### **Statement of Issues or Questions Addressed**

Board of Education Policy 7110 has not been revised since its adoption in 1969. Staff recommends that the policy be revised. These amendments will clearly articulate the Board's philosophy of planning quality schools and its relationship to promoting student achievement. The revisions also reflect current school system business practices, as well as the Policy Review Committee's editing conventions.

## **Determining Needs**

## I. PHILOSOPHY

The Board of Education OF BALTIMORE COUNTY (BOARD) MUST BE RESPONSIVE TO CHANGING ENROLLMENT PATTERNS TO SUSTAIN HIGH QUALITY EDUCATIONAL PROGRAMS FOR ALL STUDENTS. THE BOARD FURTHER recognizes THE NEED TO HAVE A COMPREHENSIVE AND COORDINATED APPROACH FOR PLANNING SCHOOL FACILITIES IN ORDER TO PROMOTE STUDENT ACHIEVEMENT [the significance of providing school facilities that enhance the educational program].

#### II. IMPLEMENTATION

- A. THE SUPERINTENDENT SHALL ESTABLISH PROCEDURES [To] THAT ENSURE [assure a] comprehensive [approach to] planning. IN DEVELOPING THESE PROCEDURES, THE FOLLOWING FACTORS SHOULD BE TAKEN INTO CONSIDERATION. [needs, the following aspects shall be considered:]
  - 1. THE CURRENT AND PROJECTED DEMOGRAPHICS OF THE STUDENT POPULATION;
  - 2. IMPLEMENTATION OF THE INSTRUCTIONAL PROGRAM;
  - 3. COMMUNITY INVOLVEMENT:
  - 4. THE AVAILABILITY OF FISCAL RESOURCES FROM ALL FUNDING AUTHORITIES.
  - [1. The expanding and changing educational program of the school system.
  - 2. Relations with the total community.
  - 3. Safety and welfare of pupils.
  - 4. True economy reflecting full value for each tax dollar expended.
  - 5. Plant and site aesthetics as they affect the education of pupils and feelings of citizens about their schools.
  - 6. Changing makeup of the population as to age distribution, educational levels and the like.
  - 7. Community planning and zoning.
  - 8. Financial resources of Baltimore County and the State of Maryland.
  - 9. Relationship between projected new facilities and those already in existence.

The Superintendent of Schools shall establish administrative arrangements considered necessary to determine such needs. In so doing, a wide range of resources may be drawn upon including, but not limited to, the area utility, commercial, industrial, and governmental entities; as well as staff personnel and educational consultants.]
